

**SPECIAL DISTRIBUTION BENEFITS AMOUNTS
FOR CLASS MEMBERS APPROVED UNDER THE TRANSFUSED PLAN AND HEMOPHILIAC PLAN**

Note: It is important to note that approved class members are paid the same amount for Plan benefits and Special Distribution Benefits regardless of which Plan they are being paid under.

For those under the Transfused HCV Plan or the Hemophiliac HCV Plan who had previously been paid their benefits, the 2017 Special Distribution Benefits were issued as a separate payment starting in 2018. The additional Special Distribution Benefits created by the Courts in 2018 and 2023 were also issued as separate payments, where applicable.
